The Lewis Fluhart house is located on the East side of Black Walnut Point Road on Tilghman Island in Talbot County, Maryland. This house, which is one of the Island's six remaining W facade houses, is really an ell with a central, two-story, projecting bay. The house faces west, with one wing of the ell extending to the northwest, and the other wing extending to the southwest.

Built around 1892, the Fluhart house has been reworked within the past year. The exterior is clad in beaded weatherboard siding and the roof is covered with asphalt shingles. The foundation, formerly brick piers, has been raised and replaced by cinderblocks.

The west (main) facade has a central two-story, three-sided, projecting bay. The first floor of this bay has an entrance door with sidelights and a three light transom. This door is flanked by a single pane window on either side. Originally, the house had a one-story porch with turned supports and a scroll work balustrade which wrapped around the central bay. Although not yet in place, the current owner intends to rebuild this porch. One-over-one sash windows flank the central bay of the first floor. The second floor has a central one-over-one sash window with single pane windows on either side, and the central bay is flanked by one-over-one sash windows. The attic story of the projecting bay has a peaked roof which breaks inward towards the main block of the house. A pointed arch window is inset into this attic story.

The southwest gable end elevation is lit by one one-over-one sash window on the first story and one one-over-one sash window on the second story.

The southeast elevation of the Fluhart house has a central projecting gable roof bay with a single one-over-one sash window on both the first and second floors. The western bay has a bay window on the first floor, with a pair of one-over-one sash windows on the second floor. The first floor of the eastern bay is a modern addition, while the second floor is blind.

The southern bay of the northeast elevation is a gable end with a pair of one-over-one sash windows on the second floor and a modern addition


The .36 acre property for the Lewis Fluhart house was given as a wedding gift to Lewis Fluhart and Sallie Cummings by her parents, Lewis P. and Sarah F. Cummings, in 1892. Lewis Fluhart operated a store on the Island, and his ledger and some family letters were found in the house during the recent renovation by the current owners. According to Tom Faulkner, one of his grandfather's diaries notes that lumber for the Fluhart house came from the Sharp's Island Hotel.

Although the interior and exterior of the Fluhart house has been completely reworked, the exterior plan of the structure remains distinctive as one of the few W facade houses extant on Tilghman Island. The Fluhart house is also the only house of this unusual design located on the Island outside of the village of Tilghman.
