The P. M. Pastorfield, Jr. house is located on the south side of Royal Oak Road in Royal Oak, Talbot County, Maryland. This house is the second structure on the west side of Royal Oak Road from its intersection with Bellevue Road. The house faces north with the principle gable oriented on a north/south axis.

Built after 1889, this two bay, two-story frame structure is sheathed in white, german siding and finished with cornerboards. The foundation is brick and the roof is covered in asphalt shingles.

The north (main) elevation is a gable end with a full width screened porch with square post supports resting on a cement pad floor. The first story is pierced by a four panel door with a four-light transom and three-light sidelights. One two-over-two sash window with narrow surrounds and blue louvered shutters lights this first floor. The second floor is lit by two two-over-two sash windows with narrow surrounds.

The east elevation is lit on the first floor by one two-over-two sash window with narrow surrounds and on the second floor by two two-over-two sash windows. A two-story, gable roof addition extends to the south with a one-story, shed roof addition across its first floor. The first floor is lit by three single light windows. The second floor is lit by one two-over-two sash window with narrow surrounds.

The south elevation has a shed roof addition which extends across the first floor lit by two sets of two single-light windows. The second floor is lit by two one-over-one sash windows with wide, white surrounds.

The west elevation is lit by two two-over-two sash windows with narrow surrounds on both the first and second floors. A two-story, gable roof addition extends to the south lit by a three-sided bay window with eight-light windows. The second floor has one two-over-two sash window with narrow surrounds. A one-story shed roof addition projects to the south from the southern end of this two-story wing. The south side of this structure is pierced by a set of sliding glass doors.

The gable roof outbuilding which sits on the property was once the Royal Oak post office. It was moved from its original site next to Royal Oak Road to the rear of the property. The former post office is now covered with

Prepare both a summary paragraph of significance and a general statement of history and support.

Bernice Leonard writes about this property in Twig and Turf III. This lot was the extreme northernmost portion of the "Locust Lot" which Joshua E. Leonard had sold to Anthony Banning in the mid 1800s. Banning's heirs then sold the property to E. T. Benson in 1862 who sold it to P. T. Pastorfield. Pastorfield exchanged this lot for a site on Ferry Neck (Bellevue) Road owned by Thomas J. Valliant. Valliant then became the owner here.

In 1871 Valliant was forced to give his property in a Deed of Trust to Ormond Hammond. Hugh B. Valliant purchased this lot at a trustee sale in 1877. In the 1877 Atlas a house is located on this property with "H.B. Valient" identified as the owner. Valliant did not have the money to pay for it, however, and soon lost the property to Ormond Hammond in a Deed of Trust. In 1884 Hammond sold the property to Mary C. McNeal.

In 1889 John B. and Mary C. McNeal lost all the buildings on this property in a fire. The following year they sold it to Samuel Stewart who conveyed it to Mary Louise Thompson in 1893. In 1910 Thompson sold the property to Eva M. Myers who then conveyed it to P. M. Pastorfield Jr. in 1916. The Pastorfields, whose shop was just next door, retained ownership of this property until 1957.

During Samuel Stewart's ownership of the site, he leased a part of the property to Richard H. Meeds. Meeds had been appointed Royal Oak postmaster in 1890 and he built a small building here which served as both a store and a post office. This building still stands although it has been modified and removed from its original site next to the road to the rear of the property.


