DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Knoxville Post Office is a front gable roofed two story frame rectangular building which faces west from the east side of Route 180 (Jefferson Pike) in Knoxville.

The principal facade is three bays wide. The main entrance is original twin glass and panel doors. The underpanels are hipped shaped with upper two lights with a beaded molded cornice and one light transom. Flanking the main entrance is the original glass and wood storefront with three horizontal 2/2 windows with diagonal paneled apron. A plain molded cornice is located over the entire first floor of the building. Located on the second level of the principal facade are three original 2/2 windows with plain molding and cornice. A 1/1 window with decorative triangular molding and applied wood cut out decoration located over the window is centered in the front gable.

The building is three bays deep on the north and south sides. Two 2/2 windows with plain molding and cornice are located in the first two bays with identical windows located in all three bays on the second level.

A one story frame loading dock with tin shed roof and cinder block platform extends southward from the southeast corner of the building.

One 2/2 window identical to the other windows on the building is located on the first level in the northeast corner of the building. Three additional windows are located in each bay on the second level. Two additional windows are located on the second level in the rear gable with a small four pane window centered in the gable.

The entire structure is built on a low random stone foundation and is covered by a front gable patterned slate roof with boxed cornice and return. An original brick chimney rises from the northeast corner of the building.

A one story vertical board garage is located to the rear of the building.




