The H. T. Beans House is a 1940 frame 1-1/2 story house with three bays and a projecting center entry bay with a steeply pitched gable and an open sun porch. It is a good example of the "mail-order house" for which plans and major materials were supplied by large mail order department stores and building firms to be constructed by local labor. The Beans House was probably a Sears, Roebuck & Co. design featured in the 1932-33 catalogs, "The Maplewood". The Beans House has the chimney, a later addition in a different location than the original model and the sun porch is also a variation on the Maplewood type.

The H. T. Beans Mail-Order House is a 1940 frame 1-1/2 story house built according to mail-ordered specifications and design on the northeast side of Point of Rocks Road and Frazer Road just outside the northeastern boundary of the city of Brunswick, Frederick County, Maryland. The main elevation faces northwest. Also on the same property are a non-contributing garage and outbuilding.

The Beans House has a simple four-room plan on the first story with two bedrooms on the second story. The three-bay main elevation has a projecting center bay with an extended, steeply gabled roof containing the entrance. An open first-story porch is located on the west end of the house. An unsheltered rear porch extends across the southeast elevation. The exterior siding is asbestos, covering the probable clapboard or german original siding. The roof is composition and the raised basement is rusticated concrete block painted white. A shed dormer is located on the rear roof slope. The fenestration is 1/1. The only major exterior changes to the house are the modern siding, an exterior brick chimney located on the west sun porch, and a metal awning extending around the cornice above the sun porch. The interior was not accessible for this survey.

The H. T. Beans House is a good example of a "mail-order house" built about 1940 with plans, major materials, and details supplied by a mail order house, in this case probably Sears, Roebuck & Co. The model is a variation of "The Maplewood", featured in the 1932-33 catalogs. The major difference between the original Maplewood design is that the chimney was not an original feature in the Beans House, having been added on the west elevation at a later date. The sun porch is also an addition to the original model. The simple plan is a feature of all the mail order house plans, intended to be built with local labor and sometimes with locally provided foundations. It is unknown at this time whether the foundation of the Beans House was of local provenance. Other rusticated concrete block foundations are very common in houses of the 1930's and 1940's in Frederick County and several building stone suppliers were active in the pre-1940 period. The projecting center gable with the steeply pitched and extended gable gives the house a picturesque, cottage-like appearance, which was a characteristic of the smaller designs. "Sears houses" are fairly numerous in Brunswick and its suburb Rosemont, which experienced considerable expansion and growth in the period 1900-1940.



THE MAPLEWOOD




The Maplewood is a story-and-a-half English type in which the front gable projection and fireplace chimney form an important part. The exterior walls are planned to be covered with gray prestained wood shingles laid with a wide exposure to form a pleasing background for the dark colored shutters, roof and chimney. A batten-type front door with ornamental iron strap hinges and English lantern above add considerably to the front elevation.

Details and features: Six rooms and one bath. Brick chimney in front; batten shutters; arched front door with strap hinges. Fireplace in living room.
