The Lloyd C. Culler House and Ann R. Beard House (F-3-25) are both examples of the carpentry work of Lloyd C. Culler, a prominent builder in southern Frederick County in the late nineteenth century.

The land upon which the house is located was purchased by Ann R. Beard from John and Charlotte Renn in August 1893. It is believed that Lloyd Culler was engaged by Beard at this time to build both houses.

According to Williams' History of Frederick County, the builder "was engaged in farm pursuits until 1889, when he started to learn the carpenter's trade under Newton Shaffer (sic) of Buckeystown District, (see F-1-56). He has been very successful in his chosen work and is one of the foremost builders and contractors in the county. He has had charge of the erection of a number of handsome buildings throughout the county. It was he who built the Frederick City Young Men's Christian Association Building, one of the finest edifices in the city." (Destroyed by fire in 1974.)

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Lloyd C. Culler House is a frame two and one-half story Carpenter Gothic cross gable roofed residence which faces east from the west side of Feagaville Lane in Feagaville.

The principal facade which is covered with German siding is three bays wide. The main entrance, a four panel door with twin upper arched panels, multipaned frame storm door, two pane side lights with underneath paneling and narrow three light transom is located in the second bay.

Occupying the remaining bays on the first level and each bay on the second level are original 2/2 windows with louvered shutters. A small 1/1 Victorian Gothic window is centered in the front gable.

A one story porch with slightly hipped composite roof supported by four full and two half turned columns extends across the entire front of the building. The boxed cornice is decorated by a frieze of rows of turned spools, dropped pendants and scrolled brackets.

The main block of the building extends two bays deep with a two bay wide frame addition extending to the rear of the house.

Occupying each bay on both levels of the north and south gable ends are double hung 2/2 windows with louvered shutters. Two four pane square windows are located at the top of each gable end.

A two story open porch which has been screened in and partially enclosed on the first level extends along the entire south side of the addition. The second level of the porch has remained unchanged with a plain railing and plain square wood columns.

A four panel door with one light transom is located in the first bay on both levels. Double hung 2/2 windows with louvered shutters occupy the remaining bays on each side of the addition.

The entire building is constructed on a low random stone foundation and is covered by a replaced standing seam tin roof with cast iron snow birds.

A boxed cornice with decorative barge and vergeboard on the front gable encompasses the building. Dropped pendants hang from the top of the north and south gables. Two original single corbeled brick chimneys rise from the building on the north and south gable ends.

Located to the rear of the main residence is a two story gable roofed frame outbuilding with exterior shouldered brick chimney which was used for butchering and chafing, and a small vertical plank house barn.


