The Hemp-Miller Farmstead is centered on a circa 1804 brick dwelling with a stone and brick rear wing expanded in height in the period 1820-1850 and a stone and brick, two-story smokehouse built about the same time as the main section of the house. The farmstead also includes a large, frame and stone bank barn built in 1875 and dated in the gables, a concrete block milk house of about 1920-1925, and a family cemetery with graves dating as early as 1804. The farmstead is principally important for the architecture of the 1875 barn, an excellent and well-preserved example of the late 19th century bank barn. The house and smokehouse are moderately significant examples of vernacular domestic architecture of the first quarter of the 19th century. Both have been sandblasted and repointed as part of extensive recent rehabilitation.

7.1 Description (Continued)

Barn: The large white-painted frame barn has a stone foundation with the ramp to the hay loft on the south elevation. A non-contributing concrete silo is located next to the ramp. Three sets of sliding doors extend across the south elevation. The roof is standing seam metal. The upper structure has vertical siding with rectangular louvred vents in the east and west gable ends. In the east gable is a diamond panel outlined by molding in which the date 1875 is painted. On the west gable, the diamond shape and date are painted, without the molding frame. On the north elevation, the stalls are enclosed by a stone wall, with a partial concrete block alteration at the northeast corner for a milking room. This probably was built in the 1920's. A small concrete block milk house of about the same date is located near the southeast corner of the barn. It has 6/6 pivoting sash, a standing seam metal roof, and a tongue-and-groove paneled door with a glazed upper panel in the south elevation.

The Hemp-Miller Farmstead is an originally agricultural complex, now principally a private residence centered on a circa 1804 brick dwelling with a two-level brick and stone smokehouse built about the same time, and a frame and stone bank barn dated 1875 on the east and west gables which is still in use as a cow barn and hay storage structure. A concrete block milk house of about 1920-1925 is near the barn. Also contributing to the farmstead is a small family cemetery in a grove of trees about 50 yards east of the buildings. The farmstead is located on the north side of Utica Road less than 1/2 mile east of Hessong Bridge Road near Lewistown, Frederick County, Maryland. The house faces south and the building group is set back from the road about 50 yards. The date of the house and the smokehouse was estimated by architectural details and land records.

The house has a five-bay south elevation in flemish bond. The entire brick exterior has been sandblasted and repointed, with some areas of brick deterioration. The entrance is in the center bay with a multi-paneled glazed door of about 1880-1890. The window openings have gauged arches with 1/1 replacement sash and louvred shutters. The cornice is boxed with bed molding and interior end chimneys rise at the east and west gable ends. The roof is covered with standing seam metal. A one-story porch extends over the center three bays, with turned columns, brackets, and a concrete deck. The flat roof of the porch and the large scale of the columns and brackets suggests that it is a modern reproduction. The east and west elevations have two bays each and are in 5:1 American bond. A two-story stone and brick rear wing extends from the northwest corner. The west elevation has a corbeled cornice, indicating the original one-story stone wing was raised to two stories about 1820-1850. A modern one-story porch with square posts is on the west side of the wing. Doors and windows alternate in four bays. The north end of the wing reveals the original height of the stone section, with the brick wall above terminating in an interior chimney. The east side of the wing has a two-story porch, enclosed on the first story by modern 6/6 windows over a vinyl-sided base and including a screened section. The porch is supported on stone piers.

The interior of the house has been divided into two apartments, one on each floor. The first story has a center hall with wall-to-wall carpet and linoleum flooring covering the original floors. The stairway retains scroll closer ornamentation and a simple chair rail which continues up the stairway as half-round molding. The simple molded mantels in the east and west parlors are in place, but the fireplaces are closed. The northeast room has been converted to a modern kitchen. The other areas of the house were inaccessible for this survey.

Smokehouse: The two-story smokehouse has a stone first level and a brick second level. A replacement tongue-and-groove door with strap hinges on the south elevation opens into an enclosed space with a fireplace recess on the north wall. A second door opens on the west elevation. The second story on the south elevation has a similar doorway. A 6/6 window on the east elevation is a replacement. The gable roof is composition and the extended eaves indicate that it has been rebuilt.

The Hemp-Miller Farmstead is significant principally for the architecture of the 1875 bank barn, an excellent, well-preserved example of the late 19th century bank barn. Information on the barn builders has not been discovered; however, a similar barn with the date 1882 is located about 2 miles to the east at the Doctor R. Wachter Farmstead (F-3-79). Further survey in the Lewistown area may reveal information about the builders. The Walkersville Planning Region adjoining the Lewistown area on the east has several large barns of the same general date and design and they are typically painted white, rather than red as was more common in the late 19th century, especially in the Middletown and Brunswick Regions in the western part of the County. The dwelling and the smokehouse are moderately significant as representatives of domestic vernacular architecture of the first quarter of the 19th century. The modern alterations and the sandblasted exterior have resulted in some integrity loss. The house was probably built by Henry or Philip Hemp about 1804.

Land records indicate that the two Hemps, presumably brothers, began purchasing land in the vicinity in 1800, continuing to 1818. The earliest readable dated stone in the family cemetery is 1804 and the stones have initials ending in "H", according to Ms. Lynn Steele, one of the tenants in the house. By 1856, Eva C. Hill, widow of John Hill, had purchased the farm, then encompassing 174 acres. George W. Miller (ca. 1835-1906) married Caroline Hill and bought the farm from his mother-in-law in 1868. He had the barn erected in 1875. Cited in the 1910 History of Frederick County, Miller was described only as "a successful farmer", which is clearly supported by the size and craftsmanship of the barn. The Miller family donated the wooded section of the farm north of the farmstead, "Miller's Woods", as a church picnic grounds, for which it has been used into the present time.






