The Central Chapel is a small one story whitewashed stucco over stone rectangular church, three bays wide and three bays long, banked against a small hill and built on a high random stone foundation.

Twin arched paneled doors with decorative wood lintels are located in the first and third bay on the east side. Occupying the second bay is a double hung segmented gothic window with louvered shutters. Directly over the window a plaque states, "Faith, Hope, Charity, these three but the greatest of these is Charity - I Corinthians 13, Verse 15" and "Central Chapel, 1843."

In 1831, Cordelia H. Downey gave to the trustees of the Central Chapel a one acre tract of the Resurvey on Drummine "for the purpose of erecting a house of public worship together with the privilege of a spring upon the premises of Cordelia Downey. (The)...house of public worship to be used for the accommodation of all denominations of Christians who may wish to occupy it as such." The building, however, was not built until 1843 but is still one of the oldest churches remaining in the New Market region.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Central Chapel is a small one story rectangular church which faces east from the westside of the Green Valley Road (Route 75) near New London.

The whitewashed stucco over stone structure is three bays wide and three bays long and is banked against a small hill and built on a high stone foundation.

Two twin arched paneled doors with decorative wood lintels are located in the first and third bay on the eastsides. Occupying the second bay is a double hung segmented gothic style window with louvered shutters. Directly over the window a plaque states "Faith, Hope, Charity, these three but the greatest of these is charity. I Cor 13, Ver 15" and "Central Chapel, 1843."

Windows identical to that in the second bay on the principle facade are located in each bay on the north and south sides.

The tin, gabled roof is finished by an architaved boxed cornice with return. A small interior brick chimney straddles the gable on the west end.




