Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Stonehurst property is located on the northeast side of Waynesboro Road just beyond the western boundary of Emmitsburg in northern Frederick County. The house is sited on high ground immediately adjacent to and overlooking the road.

The house is oriented on a north-south axis at about a 45 degree angle to the road, with a multi-part wing extending to the rear. It is a square, 2 1/2 story brick house with a pyramidal roof surmounted by a cupola. It is three bays wide and three bays deep with a one story bracketed porch carried around three sides. The square massing of the main block, the fine porch with both scrollwork and cast iron decoration, a heavy bracketed cornice and the widely proportioned cupola provide the principal focus for the house and convey a sense of dignity and charm that makes this a distinctive landmark in the Emmitsburg area.

A two story brick wing extends to the rear. It is three bays long and one room deep with a shallow pitched gable roof. A second two story structure has been joined to the rear wing by a one story hyphen.

The house known as Stonehurst was constructed circa 1875 by Joseph Hays, who had purchased 48 acres of the larger Stonehurst tract in May of 1868. Mr. Hays' son sold the property in December 1905 to Reverend John G. Murray, who renovated the house and added the cupola.

A brief reconnaissance survey of the property was sufficient to determine that the house should be entered in the county and state historic sites inventory, and further research and fieldwork is clearly merited. Based on exterior evidence and the existing historical research, the house also merits review for potential eligibility for nomination to the National Register of Historic Places.


This lovely brick "family" home, poised atop a private knoll, features panoramic views of beautiful Frederick County.

Located on Waynesboro Road, it is adjacent to the Historic City of Emmitsburg, just a short distance from recreational facilities as skiing and golfing, plus a comfortable commute to Baltimore and Washington, D.C.

Emmitsburg is the home of Mount St. Mary's College, the National Fire Academy and the Shrine of St. Elizabeth Seton.

Built circa 1875 by Joseph Taylor, this home was renovated and improved by the Right Reverend (Bishop) John G. Murray around 1910. It was then that the cupola was added, which has become a favorite landmark of long-time residents of the area.


