The Frederick and Emmitsburg Turnpike Road Company Tollhouse is located on a North Franklinville Road which was formerly a turnpike running north towards Emmitsburg, Maryland. The building is closely aligned to the road. The principal elevation faces east with the gable roofline running north to south. The tollhouse is significant as one of the few remaining tollhouse buildings in Frederick County. Toll turnpikes were important in establishing travel routes throughout the region; tollhouses evolved as a building type associated with the turnpikes. In form, plan, and materials, this tollhouse is representative of its type.

7.1 Description:

The Frederick and Emmitsburg Turnpike Road Company Tollhouse is located on a North Franklinville Road which was formerly a turnpike running north towards Emmitsburg, Maryland. The building is closely aligned to the road. The principal elevation faces east with the gable roofline running north to south.

Constructed in 1879, the one story brick building has 5:1 common bond brickwork and rests on a stone foundation. The gable roof of standing seam tin has two interior end brick chimneys. There is a corbelled cornice on the east and west elevations and raking boards on the gable ends.

The main (east) elevation has a symmetrical 3 bay facade. The center door has a transom light and a flat wooden lintel and is covered by an entry porch with a shed roof. It is flanked by two 6/6 windows with flat wooden lintels. The west elevation has only one opening: a door with side placement. The north gable end is one bay wide with a center 6/6 window with a flat wooden lintel and a soldier course above the lintel. There are two 4 light attic windows with flat wooden lintels and two basement windows with flat wooden lintels and soldier courses. The south gable end is the same as the north except it does not have the basement windows; instead, it has a door into the basement level.

The interior has a two room plan. There is a boxed staircase to the upper attic/loft level. There is some tongue and groove board on a door and on the staircase. The building has deteriorated but retains some of its original plaster and woodwork.

The tollhouse is scheduled for demolition by the owners in the summer of 1991.

8.1 Significance:

The Frederick and Emmitsburg Turnpike Road Company Tollhouse is significant as one of the few remaining tollhouse buildings in Frederick County. Toll turnpikes were important in establishing travel routes throughout the region; tollhouses evolved as a building type associated with the turnpikes. In form, plan, and materials, this tollhouse is representative of its type.

Tollhouses, once numerous in Frederick County, are becoming a rarity. There are very few surviving in the county. One extant example is the Woodsboro and Frederick Turnpike Company Tollhouse (F-8-1) near Walkersville; this building was restored in the 1980s for commercial use. Its original context has been altered by a surrounding housing development. The Frederick and Emmitsburg Turnpike Road Company Tollhouse compares to this example by retaining its historic setting with minimal intrusions. Although it is structurally unsound, the building has retained original materials, form and appearance.


There was a movement towards improving the road system in Frederick County beginning in the early nineteenth century. Road improvements were needed to boost the agriculturally-based economy of the county. Turnpikes began to be constructed under the auspices of private companies owned by local citizens. These turnpikes were based on a toll system which helped to support their operations. Many tollhouses were constructed in conjunction with the building of turnpikes.

The Frederick and Emmitsburg Turnpike Road Company Tollhouse was probably constructed in 1879 (Land Deed 1359, 799). The turnpike company purchased a 1/4 acre parcel and a 1/16 acre parcel in 1879. Both parcels were part of the tract, "Empty Pocket". The company owned that land until 1911 at which time they sold the property to Minnie Seiss (Land Deed 298, 245). The building probably operated as a tollhouse from 1879 until 1911. After 1911, it was utilized for a residence.
