7.1 Description:

The Smith Road House is located on Smith Road in the vicinity of Emmitsburg, Maryland. The principal elevation faces south with the gable oriented on a east-west axis. A garage is located to the south of the house across Smith Road.

Constructed circa 1880, this two story frame building is sheathed in aluminum siding and has a stone and concrete foundation. It is characterized by narrow proportions (two bays wide) and a small scale. The gable roof is covered in standing seam tin and has one exterior end brick chimney. A one story side addition is attached to the west elevation of the main block and has a standing seam gable roof.

The main (south) elevation is 2 bays wide with symmetrically placed openings. The first floor has a 2/2 window and a door opening; the second floor, two 1/1 windows. A one story open porch extends the full facade and has a shed roof of standing seam tin and square columns. It is decorated with carved bargeboard. The south elevation of the addition is two bays wide. It has a paired window with 6/1 lights and a door. The north elevation has 1/1 windows. It is covered by a one story enclosed porch with a shed roof and bay windows.

The east gable end is one bay wide with symmetrical windows: a 2/1 window on the first floor, 1/1 on the second, and an attic vent window. The west gable end has the same openings as the east. The one story side addition has a paired window.

The garage is comprised of two sections: a gable-front section and a flat-roofed section. Each section has a large door opening. The building is sheathed in asphalt shingling. The roofline is covered in corrugated tin.

8.1 Significance:


The Smith Road House represents an unusual example of late nineteenth century vernacular architecture in the region. It is a two story, two bay building with narrow proportions and a small scale in a rural setting. Its appearance seems better suited for town landscape rather than rural landscape.

This building has undergone typical alterations and changes seen in the county including the use of siding and replacement windows. In form, however, the building demonstrates a vernacular design not common in the county. One other example of this type is located approximately 3/4 miles from the Smith Road House on 15663 Kelbaugh Road.


The Smith Road House was probably constructed circa 1880. The area between Thurmont and Emmitsburg experienced growth and development during the late nineteenth century and into the early twentieth century. The property was a part of the concentration of late nineteenth century building on Smith Road.
