7.1 Description:

Kelbaugh Road extends southward from St. Anthony's Survey District for approximately one and one-half miles with a concentration of log buildings. The density of buildings terminates at the intersection of Kelbaugh Road and Helmer Road. An off-shoot of St. Anthony's Survey District, this area has approximately 23 buildings situated on the east and west sides of Kelbaugh Road.

Most of the buildings on Kelbaugh Road date from the late nineteenth century; there are also some early twentieth bungalows. The buildings are architecturally homogenous with the majority being log and/or frame. All of buildings are sided with various materials including stucco, asbestos shingling, aluminum siding, perma stone, weatherboard and wood shingles. The buildings range in height from one to one & one-half to two stories; the average width is three bays.

One building that exemplifies the Kelbaugh Road houses is located on 16139 Kelbaugh Road. Built circa 1870, this two story log building is sheathed in wood shingling. The gable roof of standing seam tin has one interior end brick chimney and two exterior end concrete chimneys. A one story rear ell extends from the east elevation. It has a standing seam tin gable roof and rests on a stone foundation. A one story outbuilding, covered in composition shingling, is situated to the east of the house.

The main elevation faces west towards Kelbaugh Road and has a three bay facade. The first story has a center door and two 2/2 windows; the second story has two 2/2 windows. A one story hipped roof porch is open and covers the full facade. The east elevation also has 2/2 windows. The north gable end has one 2/2 window on each floor, asymmetrically placed. The south gable end is two bays wide with symmetrically placed 2/2 windows on each floor.

The main facade of the rear ell faces south with two bays: a 2/2 window and a door. The north elevation has three openings with 2/2 windows. There is also a window in the stone foundation. The east gable end has three 2/2 windows, asymmetrically placed.

This house demonstrates the use of log construction into the late nineteenth century within this concentration of housing. It has undergone limited alterations and has an average level of integrity. Its fair to average condition is representative of the other buildings along Kelbaugh Road.

8.1 Significance:

The Kelbaugh Road House is one of the principal buildings in concentration of housing located on Kelbaugh Road in close proximity to St. Anthony's District. The house is representative as a log building with a typical form and plan for the area. The density of approximately 23 buildings along Kelbaugh Road indicates a small community that developed in the mid-to-late nineteenth century with its focal point being St. Anthony's. The building exemplifies the vernacular housing of that community.

Within its historic context, this building can be compared to the buildings in the immediate vicinity on Kelbaugh Road. It provides one of the more original examples within the concentration of housing with a good level of integrity. The Kelbaugh Road houses comprise an extended area of St. Anthony's; such extended areas are seen in other regions of the county and vary in size and housing. (One smaller example is Troutville, F-8-100, outside of Woodsboro.)


This area developed between 1858 and 1873. By 1873, a number of the buildings had been constructed, and the burgeoning community included a store and two carpenter shops. J. Kretz may have owned 16139 Kelbaugh Road in 1873.




