This two story log house was built as the residence of a white land-owning family of moderate means. In plan it consists of two rooms down and two up, both rooms being approximately the same size. In plan, size and construction the house resembles the homes of other white and black families of modest means in the county.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story abandoned log house stands on the north side of Comus Road (south). The yard in front and around the house has grown up in small trees and shrubs, but the house is still clearly visible and is in relatively sound condition. The windows and doors are boarded over.

The facade consists of the typical three bays: a door centrally placed, flanked by a window on either side. The front door is sheltered by a shed roof porch supported by square, plain posts. The roof of the porch, like the gable roof of the house itself, is covered with corrugated tin. The windows contain double hung sashes with two-over-two lights. Neither gable end has any windows, or openings of any type. The back length is pierced by a back door in the west side, and by a window similar to the others in the east side. Inside the west gable end was a brick stove, which warmed only the downstairs, since there was no opening for a pipe in the upstairs room. At the east gable end was the doorway and stairs leading down to the cellar.

The logs of the house were chestnut, were exposed, and were in-filled with cement today. There were traces of whitewash on the logs inside and out, indicating that the logs had been whitewashed during the days of occupancy. The logs were V-notched at the corners, the type common to Montgomery County.

In plan the house consisted of two rooms down and two up. The floor plan can be seen better in the measured drawing included in this survey. Between the two rooms downstairs was a central stairway, under which was a closet. In the rooms downstairs, the walls were not sheathed with siding, but the logs were left bare. On the walls were plank shelves, which were supported by boards braced against the wall. The interior was quite bare.

SPECIFIC DATES 1875-1895 BUILDER/ARCHITECT

STATEMENT OF SIGNIFICANCE
 The building materials used in the stairway, windows, and doors indicate that this house was probably built in the last quarter of the 19th century. According to Clarence Naylor and Paul Wilson who were born nearby, this house was considered to be "old" during their youth in the 1920s and early 1930s. It was occupied by a white family, the head of which was named Frank Nichols. They owned this property, and were kin to the Nichols and Cosgrave families who lived nearby on sites F: 7-1-3 and F: 7-1-16.

Since there was no deed registered listed on the tax map for the large tract of which this is only a small portion, a title search was not conducted. It seems probable that the house was built in the late 19th century, and oral informants all remember that only white families have inhabited this house.

Its primary significance is that it is one of the increasingly few log houses that has not been extensively altered and is still in good condition. Furthermore, this log house displays the strong similarity between the houses of white and black families of moderate means near the turn of the 20th century.




