Centerville's survey district is an approximately 5-acre area along the south side of Fingerboard Road extending roughly between Spencer Lane and Thompson Drive. The 9 contributing buildings are mostly two-story frame and log dwellings with modern artificial siding and corrugated metal or composition roofs. Most have three bays and one-story porches, with 2-story or 1-1/2 story rear wings and shed additions. Most houses have been considerably altered with additions to the rear and side elevations or the enclosure of one-story porches. The only non-residential building in the district is a frame tavern of the 1930's, Brown's Tavern, a functional structure which was also expanded in random additions. The district is significant as a fair example of a post-Civil War African-American community established by former slaves. It shares the characteristics of simple frame houses with little or no decoration, closely built siting, and locations within walking distance of working farms, mills, and other employment centers with other similar settlements such as Della, Pleasant View, and Hopeland, all villages established about the same time by blacks.

CONTRIBUTING RESOURCE COUNT: 9

The Centerville Survey District encompasses approximately 5 acres and 11 buildings located on the southeast side of Fingerboard Road (Md. 80) about 1-1/2 miles northeast of Urbana, Frederick County, Maryland. The district is residential in use and has 9 contributing buildings, two of which are unoccupied, and 2 non-contributing buildings. The contributing residences are mostly frame and log vernacular structures built during the period about 1870 to 1930 by freed African-American slaves. All of the houses now have modern artificial exterior siding and most have additions and extensions made during the last quarter of the 19th and the first half of the 20th century. One of the unoccupied buildings is a tavern, built in the 1930's and expanded with functional additions over several years up to about 1960. The tavern and the second unoccupied building, a dwelling, are in fair condition and the other dwellings are in good to fair condition. Dates of the buildings are based on land records, historical maps, and architectural details.

The district's buildings are generally closely built, with non-contributing modern residences more widely spaced adjoining the south end of the district and extending along two lanes running southeasterly from Fingerboard Road, Spencer Lane and Thompson Drive. One of the contributing dwellings and the two non-contributing buildings are located on the northeast side of Thompson Lane, these being the only structures in the survey district which do not face Fingerboard Road. The typical house is a two-story frame or log building with two rooms originally on the ground floor, three bays with a center entrance, and 2/2 or 6/6 windows. Most have a two-story rear wing or one-story shed addition on the rear housing the kitchen. The houses and the rear projections are simple in design and detail, in a compact, economical scale, although the modern alterations have obscured the original outlines on most of the houses to a moderate extent. Chimneys were usually located on the interior gable ends or in the center of the house. Many now have exterior concrete block chimneys or no visible exterior chimney locations. Roofs are mostly composition, corrugated metal or standing seam metal. Siding, probably covering or replacing german siding on most houses, is asbestos shingle, pressboard, aluminum, or vinyl. Following are brief descriptions of the contributing structures:

9545 Fingerboard Road: The two-story house has asbestos shingle siding with three bays on the first story and two on the second story. An originally open one-story porch was enclosed in the 20th century. The roof is standing seam metal and has an off-center chimney. The windows are 2/2. A 1-1/2 story rear wing extends from the south elevation. The house is one of several in the district built by the Thompson family. Its general form strongly suggests that it may be log and therefore may predate the earliest identified land record dated 1880. Owners: John and Ora Thompson, 9545 Fingerboard Road, Ijamsville, MD 21754.

9547 Fingerboard Road: The house has two stories and is covered with pressboard siding, with three bays on the first story and two on the second. An entry porch

Centerville Survey District is significant primarily as an example of a post-Civil War African-American community established by former slaves and other blacks. In common with Pleasant View, Della, Hopeland, and other similar settlements which were established in the southern part of Frederick County during the period about 1865-1900, Centerville is composed of simple frame and log dwellings based on the vernacular dwellings common to most of Frederick County, heavily influenced by German building techniques. The two-story houses with perpendicular rear wings are mostly altered by modern siding and later additions which obscure much of their 19th century origins. Centerville may be the only one of the late 19th century African-American villages to have a 20th century commercial building, a 1930's tavern. Located between the towns of Urbana and Ijamsville, Centerville's inhabitants walked to jobs in the area and established the Ebenezer Methodist Episcopal Church at the intersection of Ijamsville and Fingerboard Roads in about 1883. Although located about 1/4 mile from the survey district, the vicinity of the church and the neighboring schoolhouse for black children (demolished in the mid-20th century) were also considered part of the Centerville community. The 1858 Bond map shows a Methodist Episcopal church near the location of the survey district, with a blacksmith shop on the north side of Fingerboard Road. No residences are shown. The 1873 Titus Atlas map, however, has a closely ranked series of 5 or 6 dwellings marked with the names Thompson, Jones, Davis, Brown, Fairfax, and others. Land records indicate that many of the extant buildings were erected on the lands of Lloyd Thompson who died about 1906, leaving two sons and at least one daughter, all of whom received lots which had been surveyed and platted in 1905. This 1905 plat by R. A. Rager has not been located, having been in Lloyd Thompson's possession at his death.

shelters the doorway. The roof is covered with corrugated metal and a slight irregularity in the ridge may indicate the location of an original center chimney. The 1/1 windows are replacements, as are the shutters. A two-story rear extension projects on the southeast corner. The house was also a Thompson family residence, and was probably built about 1870, although the title record is only traceable to about 1880, as was that of 9545. Owner: Wilhelmina B. Ransford, 9547 Fingerboard Road, Ijamsville, MD 21754.

Unoccupied house: The only unoccupied residence in the survey district, this house has no visible house number. It is built at a slight angle to the plane of the other houses facing Fingerboard Road and is very close to 9547 on its north side. A driveway runs between the two houses to a modern residence to the southeast which is not included in the district boundary. The unoccupied house is a two-story frame or log building with hexagonal asphalt tile siding. The roof is covered with corrugated metal and an interior chimney is located at the northeast gable end. The three-bay north elevation has a center entrance with a glazed panel door. A one-story porch extends onto both the north and west elevations. The rear wing has 1-1/2 stories. The house is generally deteriorated condition. It was probably built about 1870. The owner could not be verified for this record.

9539 Fingerboard Road: This house is a much-altered 1-1/2 story building in which the structural material, log or frame, could not be determined from exterior observation. It has asbestos shingle siding and a composition roof with two dormers in the north side. The chimney is located on the interior southwest end. The window and door openings on the three-bay facade have been altered, with the entrance off-center under a small entry porch. The visible concrete block foundation may replace or face an original stone foundation. The rear wing is one story. The house may have been built about 1892 by Thomas Chase, who bought one acre of land from Ann Horman for \$50 in that year, but in a September 1916 lawsuit, the lot was described as containing a "1-1/2 story stone dwelling, a good stable, meat house, and hen house." Since the lot was split in 1925, both 9539 and 9537 may date from that period, replacing the demolished stone house. Owners: Chris D. Sprenkle and Dodie L. Waters, 9539 Fingerboard Road, Ijamsville, MD 221754.

9537 Fingerboard Road: The house is also considerably altered in its exterior appearance. It is a 1-1/2 story house with pressboard siding and a shed dormer in the corrugated metal roof. The three-bay facade has an off-center doorway sheltered by a metal awning supported on cast iron uprights. The windows are 2/2 on the north elevation, but are of various styles on the other elevations. A one-story shed addition is located on the south elevation. The house may date from about 1925, as described above. Owners: Lana E. Sewell et al, 1002 Peach Orchard Lane, Brunswick, MD 21716.


9535 Fingerboard Road: The house is a two-story frame or log building with pressboard siding and a three-bay first story. A one-story porch with cast iron columns shelters the center entrance. The second story has two bays. The windows are 1/1 replacements and the louvred shutters are also modern

replacements. An interior chimney and an exterior concrete block chimney are at the gable ends. The roof is corrugated metal. The two-story rear wing extends from the south elevation. A non-contributing garage is located behind the house. This house was probably built about 1877 by Alfred Thompson, who bought a total of 72 square perches for \$80 in two deeds from Thomas Clagett in that year. Owners: Floyd N. and Edna M. Lyles, 3819 Big Woods Road, Ijamsville, MD 21754.

9527 Fingerboard Road: This lot contains both a dwelling and the tavern, which is currently not occupied. The dwelling is a two-story frame or log house with artificial stone exterior. The three-bay north elevation has a one-story porch with cast iron columns. The second story has metal awnings at the windows, which are 2/2. The roof is standing seam metal and an interior end chimney is on the east gable end. A 1-1/2 story wing extends from the rear elevation. A one-story addition is on the east elevation. The tavern is a one-story rambling structure with no definable bay patterns and various exterior siding, indicating the several additions made to the original structure over many years. Much of the exterior has aluminum siding and groups of three windows flank a projecting foyer entrance on the north elevation. The composition roof has a deteriorated standing metal sign reading Brown's Tavern, Sandwiches and Beer. The building was probably built about 1933-1935 by Norris Brown, the purchaser of the property in 1930. Present owners: Marvin Gibbs and Ernestine M. Brown, 9527 Fingerboard Road, Ijamsville, MD 21754.

9708 Thompson Drive: The two-story log and frame dwelling has aluminum siding and a corrugated metal roof. The southwest elevation has three bays on the first story and two on the second, with a modern flat-roofed porch supported on cast iron columns. The windows are 2/2 with metal awnings. An exterior concrete block chimney is on the gable end. A 1-1/2 story rear wing extends from the northeast corner and a one-story addition is on the south gable end. The date of the house is probably about 1870, although the land records indicate only that the property was part of the Thompson family lands. In 1941, the house was described as having 6 rooms, with a small fruit orchard nearby on the 2-3/4 acre lot. Owner: Mrs. Edith M. Thompson, 9708 Thompson Drive, Ijamsville, MD 21754.




