DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Big Woods Road Bridge is a small single span steel truss bridge of pony Pratt design which spans Bennett's Creek near Urbana, Frederick County, Maryland. The total length of the span is 55 feet 8 inches; the height of the bridge is 8 feet. The entire structure, which is painted green, is covered by a replaced wood deck. The trellis railing is damaged in the southeast and northwest corner and is completely missing in the northeast corner.

The Big Woods Road Bridge is one of four twentieth century steel truss bridges in the Urbana region but is the only one in Frederick County known to have been constructed by J.S. McIlvane and Company.


