The H. Spurrier House is a 2 story cross-gabled vernacular farmhouse with a one story porch and an arched window in the front gable. The outbuildings consist of 11 frame and concrete block structures in both domestic and agricultural groups. Together, the house represents a typical mid to late 19th century vernacular dwelling and the outbuildings the development of an agricultural complex of the same period.

The H. Spurrier House is a 2-story frame residence with three bays, a center gable, and a one-story porch located on the north side of Windsor Road near the intersection of Green Valley Road (Maryland Route 75) near Urbana, Maryland. The principal elevation faces west. The foundation is stone and the exterior is covered with aluminum siding. The roof is corrugated metal. The sash is 2 over 2 and the main entrance door is paneled with a glazed upper section. The central gable has a round arched window at the peak. The house has a two-story ell extending from the rear of the main section. Five domestic outbuildings are located near the house, all with frame structures and board and batten siding. Six agricultural outbuildings are located north and northeast of the house and domestic outbuildings. The principal feature of the agricultural group is a frame barn with aluminum siding on a stone foundation. Various frame buildings with board and batten siding are placed near the barn. One concrete block and frame building and a metal shed do not contribute to the complex's significance.

The H. Spurrier House and Outbuildings exemplify a typical farm complex of the second half of the 19th century and early 20th century. Identified on the 1858 Isaac Bond Map of Frederick County as the farm of H. Spurrier, it retains a large number of domestic and agricultural outbuildings built from the mid 19th to early 20th century. The house, although altered, has the characteristic form of vernacular dwellings of the mid 19th century in its cross gable, one-story porch, and arched attic window.

The Spurrier House and Outbuildings were evaluated in the context of agricultural complexes of the late 19th century and single family residential buildings of the same period. The farm has a large number of agricultural buildings extant, where many similar groupings have been decimated by demolition and alteration. The house has a commonly seen form and detail in rural areas in Frederick and other Piedmont region counties. The addition of modern siding on both the house and some outbuildings is common and, in this case, does not obscure the historical character of the buildings.




