Cookerly's Tavern is a two and one-half story ell shaped quarried stone residence. The south section of the building is covered with narrow wood siding on the original stone walls.

The interior of the building has undergone very little change. The building exhibits a center hall floor plan with two room flankers each fifteen feet deep with diagonal fireplaces. Original hardware and woodwork including dog-eared paneled fireplaces, marbled paneled doors with HL hinges, original staircase, and random width flooring still exists in the building.

The 1808 Varle map of the area shows the existence of a tavern being operated by William Cookerly along the Woodsborough Turnpike, however, the building is not located on the Griffith Map of 1795.

In 1809 William Cookerly sold the one hundred, fifty-six acre Bear Den parcel, and two other parcels, four acres of the "Resurvey or Bear Den," and one hundred acres known as "Good Hill" to Thomas Gibson for \$8,525.00.

Gibson owned the property until his death when it was willed to a number of heirs including Henry G. Waters. The heirs sold "Bear Den" to John B. Stimmel in 1830 for \$2,000.00. Stimmel owned the property until 1860 when Isaac Renner purchased the land for \$8,795.87. Upon his death the "Home Residence" was sold to George Renner, his son, for \$4,495.00 who "was the first merchant to engage in business at New Midway."

SIGNIFICANCE (continued)

Cookerly's Tavern

The house remained in the Renner family until 1926 when the Stoner family purchased it. In 1978, the New Midway Volunteer Fire Company purchased the property.

More research is needed to confirm the legends of George Washington and Francis Scott Key visiting the tavern however, certainly the building is of local interest as the residence of George Renner, merchant of New Midway.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Cookerly's Tavern is a two and one-half story ell shaped stone residence which faces east from the west side of Route 194 in New Midway.

The principal facade is five bays wide. The main entrance, original twin four panel doors with recessed paneled entrance and five light transom is located in the third bay. A concrete block entrance porch was added to the entrance in the 1960's.

The two bay south section of the building is covered with narrow wood siding over the original fieldstone walls.

The remaining three bays of the main block is constructed of quarried stone with large quoins in each corner. The front elevation is constructed of quarried course stone, the remaining elevations are constructed of rubble stone. Occupying each bay on the first and second levels are original double hung 6/6 windows with pegged frames. Louvered shutters flank each window in the second level.

The main block is constructed on a low random stone foundation. The main block is covered by a replaced standing seam tin flank gabled roof attached by a plain boxed cornice. A single replaced brick chimney flanks the gable on the north side of the building.

A one and one-half story addition constructed of matching stone, which was added in the 1930's, extends to the rear.

The interior of the building has undergone very little change. The building exhibits a center hall floor plan with two room flankers each fifteen feet deep with diagonal fireplaces. Original hardware and woodwork including dog-eared paneled fireplaces, marbled paneled doors with HL hinges, original staircase, and random width flooring still exists in the building.

On the second level in the south rooms are located unusual bright orange marbling done in the first decade of the twentieth century. All moldings, fireplace and flooring is covered with the marbling work.

The building contains much of its original eighteenth century fabric compared to other structures in Frederick County and is worthy of preservation.

STATEMENT OF SIGNIFICANCE

Although local legend and Williams' History of Frederick County, Maryland place the construction of Cookerly's Tavern at 1717, research shows that the land was not owned by the Cookerly family until 1809 when William Cookerly purchased one hundred, fifty-six acres of "Bear Den" originally part of Monocacy Manor from the State of Maryland.¹ A survey record was made of this same piece of property for John Cookerly in 1785.²

The 1808 Varlé map of the area shows the existence of a tavern being operated by William Cookerly along the Woodsborough Turnpike however the building is not located on the Griffith Map of 1795.

In 1809 William Cookerly sold the one hundred, fifty-six acre Bear Den parcel, and two other parcels, four acres of the "Resurvey or Bear Den," and one hundred acres known as "Good Hill" to Thomas Gibson for \$8,525.00.³

Gibson owned the property until his death when it was willed to a number of heirs including Henry G. Waters. The heirs sold "Bear Den" to John B. Stimme! in 1830 for \$2,000.00.

Stimme! owned the property until 1860 when Isaac Renner purchased the land for \$8,795.87.⁴ According to Williams' History of Frederick County, Maryland, "In March, 1858, Mr. Renner removed to Frederick County, settling at what is now New Midway, having previously (sic) purchased the old Stimme! farm. Here he made his home until his death which took place June 13, 1880."⁵

Upon his death the "Home Residence" was sold to George Renner, his son, for \$4,495.00 who "was the first merchant to engage in business at New Midway. In 1884 he erected a fine stone building there and soon acquired a large and extensive trade."⁶


