7.1 Description

The Mountain View School is a one-story stone schoolhouse built about 1840 on the west side of Houck Road about 1/2 mile south of the intersection of Beaver Dam Road near Johnsville, Maryland. The principal elevation faces east and the school is sited on level ground about 20 ft. off Houck Road. The site includes a small family cemetery and a frame privy or shed located behind the school.

The school is rubble stone which has been repointed. The roof is gable with a box cornice and a corrugated metal roof. A brick chimney rises above the center ridge. A projecting gable section extends from the southwest corner of the building. The principal facade has three bays with a central 4-panel wood door and flanking window openings. All windows in the school were covered with vertical board shutters. A small gable window, also shuttered, is visible through thick ivy growing over the east and north elevations. The north elevation has two window bays. The west elevation also has two bays. The projecting section at the southwest corner has raised paneled shutters in the single bay on the south and a single door on the east.

The frame privy is located directly west of the projecting section. It has flush beaded vertical siding and a single door on the south. The gable roof is sheet metal.


The cemetery is located about 20 ft. west of the west elevation of the school. It is surrounded by a wire fence. Three headstones are inside the fence, all burials dated 1938 and the early 1950's. Other graves have been relocated, according to the occupant of 11720 Houck Road on June 25, 1991.

8.1 Significance

The Mountain View School¹ is a good example of a stone rural schoolhouse of the second quarter of the 19th century. Its ample proportions are uncommon among early schools in Frederick County and reflect its occasional use as a religious meeting house. One of the early schools of the Johnsville election district, it functioned as a gathering point for the eastern section of the district.

The context of schools in Frederick County is only partially researched. Most of those documented are now dwellings or abandoned and deteriorated. The Mountain View School is unusual for its stone material and its largely unaltered form. The interior was not accessible for this survey and needs to be documented. The religious use also needs to be researched.

¹"Mountain View School" was chosen as the historic name after much reading and cross-checking in Williams and McKinsey's History of Frederick County, in which many biographical sketches of Johnsville district residents refer to education at this school. In this researcher's opinion, the photo caption in Burns, et. al., Johnsville Election District, Frederick County, Maryland, p. 28, which shows the stone school but identifies it as "Meadow View School," is incorrect.



 Isaac Bond, Map of Frederick County, 1858


