DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick rectangular bank building located on a corner site and faced on the street elevation with white Concord granite. The Market Street side is four bays wide and the E. Patrick Street side is of three bays with an angled corner entrance, one bay wide. The doorway is of three parts including side lights and a three part transom. This is enframed by a molded surround and topped by a flat entablature supported by richly carved brackets and with dentil trim. The doorway is approached by five granite steps with low walls on either side furnishing a base for classic styled fluted bronze lamp columns topped by round globes and Roman Tuscan columns supporting the overhanging cornice. Just above the doorway is a three part paneled transom fronted by a geometric patterned iron grill and with a lighted clock encircled by a metal sculptured wreath in the center. Both street facades are of similar appearance. Each bay is separated by Roman Tuscan columns rising to the architrave. The enclosed window sections are of three parts with the top section divided by a muntin. Above these are three part transoms with grillwork and similar to the entrance transom. Footing the side windows is an elevated stone base supporting the columns and fronted by low grill covered windows to light the basement and holding planters of evergreens. The architrave which runs around the street elevation is ornamented with flat disc above the columns. Cantilevered from the roofline are overhanging molded granite cornices trimmed by flat square modillions on the soffits. A ballustrade tops the roofline which is flat and a flag pole accents the corner entrance. The building rests on a high foundation.
