DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick building, semi-detached, and square with a three bay wide, three bay long, one story wing to the rear. All brickwork is of painted common bond. The doorway to the shop is off-center in the middle bay with an entrance to the upstairs apartments on the left. The first floor facade is covered by a ceramic glass facing. Upper story front windows are of 1/1 sash with carved lintels bearing a "keystone motif" in the center. Windows on the rear of the front section are of 6/6 panes with wood lintels and sills. The wing contains two pairs of three casement wooden sashes. The roof of the front section and wing both slope to the rear and are of metal. The side walls rise to form curtains in the first bay from the front. There are several enclosed and half enclosed chimneys in the side walls. The front roofline has a boxed cornice supported molded brackets with incised designs and trimmed by molded dentils with returns around the front corners. The rear cornice is of a simple box design. The building rests on a low foundation.
