DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story building with the front half of wood and the rear of brick and it is detached on the left side. It is one bay wide and approximately six bays long. It is understood that this was built around 1893 as a fill in between the walls of the adjacent buildings. The rear section is of common bond. The first floor has a doorway on the left with a curved shop window to the right. There are two 6/6 sash on the second floor front. Rear section windows are of 6/6 sash with wood lintels and sills. The first three bays have a flat roof and the rear section has a metal shed roof. The building is fronted by a plain boxed cornice. It rests on a low foundation. In the front pavement is an inset of tiles of an old fashioned pocket watch with the name "Landis", the firm now having a jewelry store next door at #25.
