**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick building, semi-detached on the north side. It is three bays square with several more recent additions to the rear. It was built as a Federal period townhouse with a large doorway in the south bay complete with paneled door, Doric pilasters and a large, flat entablature. Windows were of 6/6 panes with molded wood lintels and sills and louvered shutters. A three string brick cornice supports the roofline. All of this is now covered by "perma stone." The building is covered by a metal medium slope "A" frame roof and a pair of twin enclosed chimneys rises from the north wall. The first floor is occupied by a store with regular large paned shop windows. The building rests on a low foundation.
