DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a high, three story detached pair of houses built of unpainted "Frederick Reds" bricks all in common bond. It is approximately six bays wide and four bays in depth and the residents share a two story brick "T" shaped wing six bays long and four bays wide with side balconies with turned pillars. Large round arched entranceways occupy the inner bays with double doors of glass, white marble sills, high transoms, and dentiled transom bars. These are framed by projecting brick architrave forming hood molds at the top. The vestibules have wood paneled wainscoating and double doors with transom bars in an egg & dart motif and dentils. Brownstone trim is used for doorway and window impost blocks and keystones; front window sills and lintels; front porch caps; buttress caps; and a wide band crossing the front above the foundation. Round arched windows lie on either side of the doorways with wide bay windows projecting above, trimmed with dentils. In between are two segmentally arched bay windows. Centered on the third story of each house is three windows in a Palladian design. These are headed by an ornamental pediment which is round arched at the base and topped by a squared block finial. The pediments are set against a shallow slate mansard roof section with stepped walls dividing and ending the houses. The base of the mansard roof is decorated by a moulded cornice and frieze with mouldings and dentils. All house windows are of 1/1 sash with first floor wing windows having two row header segmental brick arches and those above with wood lintels and sills. The front section roof slopes to the rear with stepped side walls and the wing has a low "A" frame roof. The building rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.

This house is 1/2 of a duplex. The exterior is a mirror image of # 221. Both are three story brick structures, 2 bays wide with mansard roof, 1st floor arched windows, 2nd floor oriels and 3rd floor paladian design. They are located in one of the areas of Frederick which is rapidly being restored.

3. STATEMENT OF SIGNIFICANCE:

This can be seen from the photos, this building is an important factor in a streetscape typical of the Frederick Historical District; i.e., an amalgamation of periods and styles. It is one of the few buildings in Frederick which has a parapet roof decoration. The window arrangement is also unusual in this area.
