DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Rising three stories, this building now houses two commercial establishments. It is five bays wide with the center bay being slightly off-center to the left. Its material is brick laid in common bond and painted white with white wood trim.

The first floor contains two metal and glass storefronts and an entrance to the upstairs north of the stores. The windows on the second and third floors are wood double hung with 2/2 sash and have simple jambs and sills. Over them is a variation of an elliptical pediment supported on small consoles. The cornice is typical and has large consoles on either end of the front and between the bays.
