DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a one story building composed mainly of a storefront. This commercial front is of metal and glass and has the store's signplate directly above it. Overhead of the sign is a stone band about one-half ft. high consisting of a fillet and cavetto moulding, and above that is a red brick parapet, slightly gabled, the brick being laid in common bond and having a stone parapet cap. The roof is flat and there is a chimney in the left front corner of the building.
