DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Originally, the building was a 2-1/2 story structure with a gable roof. If so, it was remodeled, for now it is three stories in the front with a flat roof. It is four bays across the front and two bays deep with a chimney stack between on the south wall. Its material is red brick laid in Flemish bond (painted white on the second and third floor fronts) with wood trim also painted white.

The first story has been faced over with new red brick and contains a wood and glass storefront and entrance. To the north of this storefront is an entrance door with a transom to the upstairs apartments.

There is a small wood cornice under the sills of the second story windows that may, at one time, have been the topmost piece of trim of an older storefront. The windows on the second floor are double hung 2/2 sash with wood sills a brick jack arch lintels. The third floor windows are identical.

The wood cornice is rather high and shallow and has patterned perforations in several of its members for air vents. There is also a frieze and architrave below it, the whole having terminal brackets at either end of the building.

To the rear of the main building are several large two and one story additions, one of which contains a balcony in a recess.
