DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The People's Drug Store building is located on the corner of E. Church and Market Streets. It is two stories tall with a flat roof. The principle materials are an orange-brown brick laid in common running bond and brownstone.

The first story on the Market Street elevation is a metal and glass storefront with a large display window, and to the north, a window of glass blocks. The entrance to the store is on the corner. On E. Church Street there is a limestone base and watertable at the sidewalk and five bays above on the first story. The farthest bay to the west is a glass display window and the remaining four are recessed brick panels. Between these panels are rusticated brownstone breaks and above them stylized brownstone jack arch lintels with rusticated voussoirs. The keystones are consoles with flat foliage on the top scrolls. The console's lower parts are fluted with the flutes containing strings of beads.

At the second floor level on Market Street are three recessed double window units of 1/1 sash. Under the windows is a brownstone belt which is carried across this elevation. Over the windows are brownstone lintels. Above the lintels in each bay is a brick panel in the recess with a horizontal brownstone band at the top and one in the center. Above this is a parapeted cap. The coner has one window at the second floor. This is a double hung with 1/1 sash, has an awning, and is surrounded by metal tiles carried up from the storefront below. The five bays on Church Street are identical to those on Market.
