DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a four story building fronting on Market Street. Its front is in three bays and constructed of a tan brick laid in common running bond. The bays are separated by false pilasters formed in the brick surface by a column of stacked brick on either side of the. The roof over the building is flat.

The first floor has a double-entranced storefront which is recent. Above the front is a soldier course of red-brown brick across the front. In each of the three bays on the second to fourth floors is a double window unit. The windows are wood, double hung with 1/1 sash. Their sills are stone and their lintels an upright course of red-brown brick. In the center bay over the second floor windows is a sign with the building's name on it.

Diamond patterns of reddish-brown brick serve as ornament on the wall surface. Small ones are placed on the false pilasters between each floor and over the fourth story windows. Larger diamonds appear over those on the second and third stories.

Atop the facade is a wood cornice. This is supported by consoles which are placed over the false pilasters between each bay. Over the cornice is a brick parapet with a soldier course of red-brown brick across its top above which is placed a stone parapet cap.
