## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building occupies a corner site. It is three stories high and is topped with a flat roof. It is constructed of red brick laid in common Flemish bond.

The entire first story of both elevations has been remodeled. The Market Street facade on this level has two wood and glass storefronts (Nos. 151 & 153). No. 151 has two display windows with segmented wood arches over them, flanking a recessed entrance. No. 153 has two display windows on Market Street with wood Roman arches over an entrance on the corner and three display windows, the easternmost one with a Roman arch, the center with a straight head, and the westernmost one with a segmented arch above it on Second Street. These last three windows are separated by the brick wall. All display windows on both facades have wood raised panels below them. Over all the storefronts and display windows on both elevations is a ~~mansard~~<sup>pitch</sup> roof of wood shingles. On Second Street to the west of the last display window is a doorway to the upstairs apartments. This is flanked by Doric pilasters and crowned with a broken pediment.

At the second and third story levels on Market Street, from left to right, are the following: A wood bay with three double hung windows with 1/1 sash, a double window unit with double hung windows of 1/1 sash (these have stone sills and jack arch lintels with brick voussoirs and stone key blocks), a single window of the same type and a double window unit identical to that described above. On the corner is a bay window identical to that on Market Street. On the Second Street elevation are eight bays. The windows are single double hung windows of 1/1 sash. They have stone sills and brick jack arch lintels with stone key blocks. All are the same size except the fourth bay from the left whose windows are smaller on both floors.

Above the third story windows is a wood cornice painted white. Over that is a brick parapet with a stone cap. The rear of the building has balconies on the second and third floor.
