DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building on the west of N. Market Street. It is constructed of painted red brick laid in common running bond. The trim is wood. The ridge of its gabled roof parallels the street and is covered with asphalt shingles.

To the far left on the first story is an opening in the wall with a wood door, probably to an alleyway. In the center of the elevation is a wood and glass storefront with the entrance between two display windows. To either side of this front is a pilaster fluted by two-thirds of its height. Above these are brackets which support a cornice over the storefront. This has three denticulated courses and a row of modillions. To the right of the storefront is a doorway to the upstairs. This has a pair of doors and over it a Roman arch filled with a transom.

The second story has four double hung windows with 1/1 sash. These have wood sills and louvered shutters. Above these is a box cornice. On the roof ridge are two brick chimneys offset five feet from the edges.
