DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building constructed of red brick laid in common Flemish bond. The roof is a gable sloping back and front and covered with metal.

The first story consists of a wood and glass shop front. The entrance with a transom is between two twenty light windows and to the right of it, a doorway to the upstairs. This latter has a pair of doors and a transom. There is one pilaster panel on each corner of the building and two between the shop front and doorway. Each of these panels has two brackets above it supporting a wood cornice. There are two more brackets equally spaced over the shop front.

The second story has three double hung windows with 6/6 sash. These have wood sills and brick jack arch lintels. Above the windows is a simple cornice. At the south end of the roof ridge is a brick chimney.
