DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story structure. It is built of brick painted yellow laid in common Flemish bond with white wood trim. The gable roof is covered with metal.

The first story front from left to right is as follows: A doorway to the upstairs apartments and over this is a transom; A shopfront composed of a door, and to its right, a small window, both with transoms; A door and window to an office, the door has a three light transom, the window is 1/1 with the top sash fixed and has an elliptical arch above it. Two feet above the window heads on this floor, two raised courses of brick extend across the front.

The second story front has four double hung windows with 6/6 sash. These have wood sills, brick jack arch lintels, and louvered shutters. Over these windows is a simple box cornice at the roof's eaves.

On the roof are two pediment headed dormers. These have 6/6 sash windows and above each window is a wood keystone. On the north end of the ridge is a brick double chimney.
