DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story building with a facade five bays wide. It is constructed of brick laid in common header bond painted red with wood trim painted white. The roof is flat.

On the first story, the first two bays to the left are filled with a sixteen light picture window, above which is a signplate and copper covered hood. In the center bay is a doorway with transom. It has paneling in its jambs and a segmented brick arch at its head. The remaining two bays have a wood and glass shop front. This has a door to the right of a divided light display window - both have transoms. To each side of this shopfront are fluted pilasters and above it is a simple cornice. The door in the center bay is original; the shopfront and window were added later, as the brick arches over the former windows can still be seen in the brickwork in the two bays left of center.

The second and third floor windows are double hung with 2/2 sash. They have wood sills and segmented arch heads. Above the third story is an entablature composed of a simple wood architrave, a brick frieze, and a wood cornice with large dentils. The whole order is supported by brackets on the corners and between the bays.
