DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story building with a facade three bays wide. It is built of red brick laid in common running bond. It is covered by a flat roof. To the rear is a two story section also with a flat roof.

To the left on the first story front is a closed window which had a semi-circular arch, still visible, at its head. To the right is a wood and glass storefront with a recessed entrance between two display windows. There is a transom panel over the entire storefront in which is an elliptical arch over the entrance. On the storefront's corners are Tuscan pilasters which support a simple entablature.

The second and third floor windows are double hung with 16/1 sash; the top sash has a column of six panes to either side of a rectangle of four. The sills are wood and over the windows are jack arch lintels with imposts painted white. At the sill line of the windows on both floors are two courses of horizontally fluted brick and at the windows' lintels are several courses of ornamented brick.

Above the third story windows is the entablature composed of an ornamented wood architrave, a brick frieze and a wood cornice with relief ornament. At the building's sides are parapets stepping down slightly to the rear.
