




DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick building detached on the left side. It is three bays square with an "L" shaped wing one bay wide and four bays in length. A former side balcony has been removed except for the overhanging roof section. All brick work is probably of common bond -- the exposed sides of the wing have been cemented over. The first floor front contains a round arched doorway with a pair of round arched paneled doors with glass panes above and a transom bar with moulded decor in the right bay. A very large paned window fronts the other two bays. Upper story windows are of 1/1 sash with segmental brick arches and wood sills. Rear windows are of 3/1 or 1/1 sash but with arches and sills cemented over. The roof of the front section slopes to the rear and the wing has a steep sloped shed roof, both of metal. The roofline is fronted by a very ornate wooden cornice moulded at the top with carved brackets interspersed with incised round motifs. Below this, the frieze is fronted by an unusual row of turned attached ballusters over a narrow band of St. Andrews crosses. ~~XXXXXXXX~~ Beneath this, the architrave is composed of a recessed panel of brick headers alternately projecting.

The building rests on a low foundation. Across the first floor area, a former hotel, hangs a cantilevered glass and metal marquee fronted by (also on the sides) a row of glass pendants.
