415-417 North Market is a three story four bay wide commercial building. The facade of the building is finished in a face brick laid in common bond. Although the first floor commercial area of the building was substantially altered in the 1960's, the remainder of the building retains its 1870's character. (continued, other side)

2. Description (continued)

Of particular importance is the decorative wood architraved hood moldings supported by brackets over each window, original twin door paneled entrance with fanlight transom and decorative dentiled and bracketed hood. A heavy dentiled bracketed cornice with pierced paneled frieze dominates the roofline of the building. A two story brick addition extends in an ell to the rear of the building. A two story open porch extends along the south side of the building.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick building detached on the left side. It is four bays wide and three bays in depth with a 2-1/2 story "L" shaped wing two bays wide and five bays long with a side balcony and another on the rear of the front section. There are several later date, one story extensions. Front brickwork is laid in unpainted Flemish bond while other brickwork is of common bond. The main doorway leading to the upper floor lies in the right bay and is very attractive. It contains double doors with small paned glass and panels beneath. The soffit and embrasure are paneled. Above the doorway is a three paned overlight. Framing this is a Victorian style enclosure consisting of paneled pilasters topped by fluted consoles and carved blocks supporting a moulded flat entablature trimmed by a row of dentils. In the left bays is an attractive colonial style shopfront built about twenty (20) years ago and has a large window of small panes and a small paned colonial door with a fluted panel separating them. Above this and in line with the right side entablature is a simple moulded cornice holding a green and white striped awning. Second floor front windows are of 6/6 sash with attractive flat moulded cornices supported on small moulded brackets and trimmed by a neat row of small dentils. Rear and side windows are of 6/6 sash with wood lintels and sills. Rear doors have four panels and old style four paned overlights. Two small four paned windows light the front section attic from the left gable, and a six paned sash lights the end of the wing attic. The front section has a moderate slope metal "A" frame roof with a wide enclosed chimney rising from the end gables. The wing has a low slope metal "A" frame roof. A three string brick cornice supports the front and rear rooflines on the front section. The building rests on a low fieldstone foundation. Walls are said to be 18" thick.

STATEMENT OF SIGNIFICANCE

This is a most attractive Federal period building and has been well maintained. It is a valuable asset to the neighborhood of other Federal buildings. The last alteration to the first floor shop area has returned the appearance to the Colonial period (which blends well with Federal) from less recent, large paned modern shop-windows. The apartment doorway, attractive and neat window cornices, and the Colonial storefront make this building a model for other restoration on Market Street.
