2. Description of Physical Appearance:

429 North Market Street is one half of a double house which is a tall three story brick building, constructed of grey brick on the facade and red brick on the sides and rear. The entire building is six bays wide and two bays in depth with two story "U" shaped wings, two stories wide and five bays long. The houses are mirror images on the exterior.

429 North Market Street is a significant building to the Frederick Historic District as a late nineteenth century residential building with the special architectural features of grey brick, decorative preseed tin cornice and original woodwork throughout the building.




The first floor front is recessed by one bay and is occupied by large porches with turned balusters and square wood columns mounted on brick pedestals supporting the upper floors. Wooden steps leading to the porch are located at either end of the building. The main entrance to 429 North Market is located in the north bay and is occupied by a paneled door with light and transom. A large paired bracketed cornice extends along the top of the porch. A decorative pressed tin cornice extends along the roof line. The second and third level bays are occupied by double hung one over one windows and the remaining bays on the first level. A rear passage gate is located between the two houses, it is of wood board and batten construction with a decorative cut-out panel at the top.

The interior of the building is characterized by hardwood floors, and Dark stained original woodwork throughout. There are three main rooms on the first and second levels, two rooms on the third level and an unfinished dirt basement. The first floor front room is characterized by a marbelized slate mantel and paneled sliding pocket doors. The staircase is open and extends to the third level with turned balustrades and boxed newel posts. Existing baths are located on the first and second level. A second story open porch extends to the rear of the building.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, three story brick building attached on each end and containing two houses. It is six bays wide and two bays in depth with two story "U" shaped wings being two bays wide and five bays long including the first bays which are of three stories. There are short balconies ending each wing. The front elevation is faced with an off-white brick while the sides and rear are of red brick, all in common bond. The first floor front is recessed by one bay and is occupied by large porches with turned banisters and square wood columns mounted on brick pedestals supporting the upper floors. The porches are reached by five steps. Rectangular doors with transoms occupy the end bays, an enclosed passageway to the rear gardens is in the center between the porches, and there are 1/1 sash windows on either side. The passageway is of board and batten construction and headed by a wood panel with cut-out designs. All front upper story windows are of 1/1, 6/6, and small 4/4 pane sash and all with segmental two row header arches. The windows on #429 are shielded by louvered shutters. Rear doors are paneled and without overlights. The roof of the front section is rather flat whereas the wings have metal shed roofs. There is a double chimney rising from the center of the roof (front). The front cornice is quite massive but simple in design. The top section is moulded and protrudes over the frieze by a line of arcaded niches containing large flower designs with petals around the center. A small size of the design fronts the cornice between the arches. Large brackets support the cornice at the center and ends and are carved by horizontal reeding and pyramid fronted blocks with small pediments at the top. These are ended by square end drops trimmed with two acanthus leaves. The first floor is topped by a moulded cornice with paired brackets separating rectangular panels of raised moulding. This building rests on a very high foundation. To the rear are long narrow flower gardens.
