DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick building, formerly a house, attached on the right side. It is four bays wide and three bays in depth with two story, full width, newer extensions to the rear. The one behind #509 is 1-1/2 bays deep by two bays in width and #511 has a one bay deep extension and both have rear balconies. The front brickwork is laid in Flemish bond with a moulded brick watertable crossing just below the front windows and matching that of #507. A three string belt course with the top row projecting from the others is a local custom crossing at the second story level and in line with that of #507. Rear brickwork is of common bond. The first floor front has been altered to accommodate a barber shop, but the Colonial styling blends in well with the building. In the left and right bays are simple entrances with doors of small glass panes over panels and overlights with transom bars trimmed with small dentils. In the center bays is a large rectangular window of eighteen (18) small panes. These apertures are headed by flat jack arches to match the old ones on the second story. These windows have 6/6 sash. The rear extensions have 2/2 sash with segmental, two row brick header arches. The doors have glass over panels and overlights. The front section has a moderate slope metal "A" frame roof with small enclosed chimneys rising from each gable. The rear extensions have low slope metal roofs. The front roofline has a boxed cornice. The building rests on a rather low fieldstone foundation and a herringbone patterned brick pavement adds to this old building. There are flower yards to the rear. This and the adjoining house, #507, were apparently built at about the same time.
