**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 1-1/2 story brick and stone cottage with the gable end facing the street and detached on the right side. It is approximately two small bays wide and four short bays long with an "L" shaped, one story, one bay square wing which was formerly an attached smokehouse for a butcher shop. The building has been restored to a dwelling again and is in excellent condition. All brickwork is laid in common bond and the front wall is reinforced and with an "S" trimmed bracket. The entranceway occupies the right bay and the original deteriorated door has been replaced by one of Colonial styling of panels and with brass hardware. This is topped by a plain wooden lintel and framed by fluted panels on each side. This is reached by a low brick stoop. There is a small 6/6 sash in the left bay, two small four pane windows in the front attic gable and one in the rear. The rear door has six panes over panels. This house sets back from the street with a very attractive formal dooryard garden framed by the adjoining houses and fronted by a white wooden estate fence. This garden contains a lawn area surrounded by brick edged flower beds with small boxwoods, perennials, springbulbs, espaliered trees, two very old tree-shaped boxwood, and brick walks. A stone wall encloses the first floor rear of the house. The "A" frame roof and small shed roofed wing are covered with asbestos shingles. A chimney rises from the rear gable. The building rests on a low foundation. The front sidewalk is laid in a brick herringbone pattern. To the rear is a very attractive, small formal garden surrounded by an ornamental block wall. It contains dogwoods, shrubs, boxwood edged flower beds, statuary, and brick walks.
