DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached brick building three large bays wide and three smaller bays in depth with a two story, full-width block extension, two bays in depth. The front facade was originally stucco over brick but was covered with formstone during the last rebuilding project in 1953. The sides received a new coating of stucco. This church has a central entranceway of a newer classical design with Doric pilasters and a shallow flat entablature. This frames a recessed doorway of double doors in panels. Front and right side windows of the second story are of 8/8 sash with a large 6/6 sash window on the first floor of the right side. The front section of the building has a metal hipped roof centered on the front by a wide pediment, now covered by formstone. The building rests on a low foundation.
