DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story fieldstone house formerly detached on the left but now with an attached narrow fill-in wooden structure. It is approximately three bays square with a 1-1/2 story "L" shaped wing of brick, three bays deep and two bays wide now built up to two stories with concrete block. There is a side frame extension and to the rear is a one story brick extension one bay wide and two bays long with a newer covered porch above. All brickwork is in common bond. The first floor of the front facade now has a colonial style wide bay window section of small panes covered by a metal sheathed pent roof and small paned recessed doors occupy the outer bays. The whole alteration is very attractive for a building of this period. There are remains of a water table on the outer edges of the facade. Second story front windows are of 6/6 sash and protected by shutters of an unusual design. They are louvered with top panel sections decorated by cut out candlestick motifs. Rear area windows are mostly of 6/6 sash with wood lintels and sills. The attic is lighted from the left gable by two small eight pane windows. The front section has a rather steep slope "A" frame roof with a wide enclosed chimney rising from the left gable. Rooflines are enclosed by boxed cornices. The wing has a shed roof and both are of metal. This building rests on a low fieldstone foundation.
