section having been constructed c. 1885. The front section is six bays deep and is characterized by a tall boom town style facade decorated with inset panels of brick work on the upper part, a center panel with decorative dentil brickwork in the center of the front and two large show windows with eight light transoms and half round surrounds. The front door is a handsome inset panel door with five light transom and egg molding cornice. The front door has been replaced by a horizontal four lighted door with one four light sidelight. A heavy decorative dentiled cornice with architrave (wood) is located along the top front of the building. The building is constructed on a low random stone foundation.

The second(middle) section, one story laid in stretcher bond, is characterized by a stepped brick cornice and arched window openings with radiating brick voussoirs and double hung 6/6 windows. *The section is believed to date from the late 19th century.*




The rear portion of the building constructed of rusticated concrete block was built c. 1930. Brick was used to decorate the window sills and lintels. Tile covers a parapet along the edge of the roof. The windows are multi-paned metal sash, almost entirely broken out, of 12/12.



A three story brick chimney rises approximately three stories from the northeast corner of the building. The rear portion of the building is constructed on concrete block foundation. A concrete block and rubble stone wall follows the east property line which encloses a unkempt rear grass lot.



