DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is now a tall, two story detached building which is five bays wide and four bays long with a newer cement block, two story extension being one bay wide and two bays deep. The sidewalls are set at an angle according to old property lines of this block. Front and left sidewalls are covered with formstone and others are stuccoed. Entranceways are in the left bay and the second from the right and contain glass over panel doors and all front windows have 1/1 sash. The rear windows are of 6/6 sash and doors have glass over panels. The metal roof slopes to the rear. The front roofline has a Victorian cornice overhanging and supported by very long fluted brackets dividing the bays, and in between those, there is a decorative band of "U" shaped motifs, similar to those used in the second block of S. Market Street. The building rests on a low foundation.
