DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story frame, probably log, detached building and it is five bays wide by approximately four bays in depth with a rear balcony and a one story extension being 4-1/2 bays wide by one bay in depth. The framing is now completely covered by asbestos siding. The first floor front consists of a barber shop in the center and apartment entrances on either side with glass over panel doors. All windows are of 1/1 sash except a few small 6/6 sash on the rear. Rear doors are also of glass over panels. The metal roof slopes to the rear with a small enclosed chimney rising from the right side. The front roof cornice is of simple box construction trimmed by a row of dentils. The building rests on a high foundation which is brick faced.
