

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE



This is a large, detached townhouse three bays square. It has a hipped slate covered mansard roof sloping on all four sides. The center section of the front wall extends up to form a tower topped by a wide pediment. A three bay long ("L" shaped), two bay wide wing extends back along the west wall and is two stories high and extends up to the base of the front section mansard roof. It has a flat metal roof with chimneys on both sides. All brickwork is painted common bond. In the west side of the mansard roof are two pedimented brick dormers with thick bracketed shelves at the bases of the windows. There are large chimneys on both sides of the front section which are half enclosed in the mansards.

A simple, round arched doorway occupies the right front bay and has double paneled doors and half round overhead. The center and east front bays contain a high triple window with mullions separating the three lower sashes and those in the arch. The wide window arch is topped by a two course brick hood mould with a matching one over the doorway. A four row belt course extends across the front facade tying on the hoodmoulds. Four narrow windows are spaced evenly in the "tower" with a central grouping of three wider ones centered on the second floor. The west side of the front section contains a three sided wooden bay window at the second floor level, an unusual positioning. An arched window in three sections of leaded stained glass in the center of the wall lights an inner stairway. Wing windows are at irregular ~~windows~~ and there are no windows on the east side of the front section. A cornice with mouldings and a carved rope motif in the angle of the cornice soffit and frieze extends around the front section to the edges of the tower in the front facade. The house is built on a low fieldstone foundation with two low cellar windows along the front. A herringbone design brick pavement fronts the house. The owner, Miss Josephine Etchison, states that the house was built around 1835 and the third floor added about 1870.
