DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#7-11 was formerly bounded by an alley on the East before the parking deck was built. It is of three story brick construction and four bays square. All brickwork is in common bond. The first floor front is enclosed in wood with three narrow doorways and rectangular paned mullioned windows, all with elliptical overlights. The whole is crowned by a protruding cornice supported by end brackets and decorated by carved modillions and dentils. Second and third floors have front windows of 4/4 sashes headed by protruding segmental cornice hoods ended by pendants. Exposed side windows are of 6/6 sash with plain wooden lintels and sills.

The flat metal roof slopes to the rear with a small chimney enclosed in each side. The roof cornice repeats the modillion-dentil trim below. The frieze is also quite ornate with segmental sections of panels and pendants. This building rests on a field-stone foundation.
