DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large detached townhouse of three stories being three bays wide and approximately six bays in depth. The roofline is stepped down to two stories by the end of the third side bay. There is a metal roof with chimneys on the rear end of the building and a small extension is added to the rear. Brickwork on the front and sides is common bond. The entrance is in the left west bay of the front and is composed of a recessed paneled door with a four pane transom and three pane sidelights. This is enclosed by a plain entablature and plain Doric pilasters. The three windows on the second and third floors plus the two on the first floor are all 6/6 with louvered shutters and flat brick radiating arches. All have plain wooden sills but the third floor windows are shorter. Windows on the sides are 6/6 with plain wood lintels and sills and are unevenly spaced. On closer inspection, front section is three bays deep with a three bay wing along the west wall. A chimney is enclosed in the east wall of the front section. The front doorway is reached by a two step granite stoop with wrought iron railing. There is a broad overhanging cornice with richly carved Victorian brackets tied together at the ends by a wood moulded band. This rests on a ten row brick frieze protruding from the face of the front facade. The east wall has several very small windows. The third bay from the front on the west wall (left wall) contains a two story bay window-first and second floors. It is rectangular with one window on each end and two windows on the west side. It has a single boxed cornice and fluted pilasters on each side of the windows. The walls are painted, but weathering. Two rectangular basement windows lie under the first floor windows.
