DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story, five bay wide building, formerly a private home. The appearance has been ruined by the bricking in of many windows on the front and east sides. Attached to the rear along the east wall is a shorter four bay wing and a three bay wing built onto that--same height. These wings are just two bays wide. The front building has a metal "A" frame roof hipped on the front. The first bay has a regular metal "A" frame and the addition has a metal flat roof. All brickwork is in common bond. The central doorway is round arched with bricks. The two outer doors are paneled with a round arch overlight. The inner doors are the same including the overlight. A massive, modern, seven step brick porch leads to the first floor indicating a high basement above ground level. Second floor front windows are segmental arched, single pane, double hung, and sides are the same. The remaining two windows on the first floor are round arched single panes. No first floor side windows are left. Wing windows are a mixture of 1/4, 2/2, 4/1 sashes, all with flat brick arches. Four double chimneys mount the center section of the front building roof. A formerly decorative carved wood banister balcony extends along the west second floor wall of the first wing. A bracketed cornice extends across the front and two sides of the roofline. The brackets enclose sections of dentils and a panel. A two story, three sided bay window rises in the first bay from the front on the west side. It, too, is trimmed with dentils. A low brick wall along the front of the building encloses attractive plantings of evergreens.
