DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached mansion, five bays wide and two bays in depth with a two story brick "L" shaped wing six long bays in depth and two bays wide with a long side porch and gallery. This wing is three bays wide in the first bay behind the front section with a one story added side extension. The front facade is laid in Flemish bond and all other brickwork is in common bond. The classic front entranceway occupies the center bay with double doors of two panels, a rectangular transom with a leaded glass geometric pattern, moulded transom bar, a paneled enframement, and marble sill. Surrounding this are Doric pilasters supporting a dentil trimmed flat entablature. This is approached by a double ended marble porch with a paneled front wall with short round pillars at either end. A cast iron greyhound dog, ~~C1800~~ 1850, lies "couchant" (probably cast in Baltimore) on this front wall, and is a Frederick landmark. All house windows are of 6/6 sash with louvered shutters. Front windows have flat brick jack arches and wing windows have wood lintels and sills. The attic is lighted by two 6/6 pane windows in each gable. The front section has a moderate slope "A" frame slate roof with wide enclosed chimneys rising from each end and the wing has a metal shed roof. The front roofline is ended by a moulded boxed cornice with small cyma-curved modillions and the rear roofline also has a moulded boxed cornice. This house sets on a rather high fieldstone foundation with an old cast iron cellar window enclosure on the front lettered "DOUB GLAZE VULCAN WORKS" eith sculpted lions in each corner. The pavement is of herringbone patterned brickwork and the wing area has a brick patio and gardens with trees and flower beds.

STATEMENT OF SIGNIFICANCE

This stately Federal home enhances the Court Square area by its generous proportions and simple lines representative of the early 19th century period, even though built slightly earlier. It is well maintained and the cast iron greyhound dog on the porch has caused it to be a landmark for more than a century. This house was used as a military headquarters during the Civil War (?).
