**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#101 is a two story, three bay square brick house detached except for a former "L" shaped wing, now a separate residence (see 119 W. Church Street). It is faced with unpainted pressed brick in common bond. The main entranceway occupies the right (N) bay with double doors of panels (top rounded), a white marble sill, tall louvered shutters, and a round arched transom of thin shaped voussoirs. This is approached by a low brick porch with urns of flowers. The wide vestibule has double doors of similar shape but with ornate mouldings. First floor front and left streetside windows are tall 2/2/2 sash with old wire mesh window box grills with cast iron motifs. Those on the second story are of 2/2 sash and all have flat brick arches of thin-shaped voussoirs. On the left side of the house is a five sided, first floor bay window on a brick base with 4/4 sash, mouldings, and an overhanging cornice with double trim and Victorian-cut brackets. The metal roof has a very unusual-shape with low gables on the rear and right sides and joined on the left side. There are four double flue chimneys rising from various points of the roof. An overhanging moulded cornice adorns the front and left side rooflines with square modillions and dentil trim on a raised brick frieze. This house rests on a low fieldstone foundation. It is surrounded on three sides with flowering trees, evergreens, boxwood, and seasonal flowers. This is enclosed by a low brick wall supporting an old cast iron fence with an iron gate of similar design held by brick pillars topped by ornamental urns. The front and side pavements are in herringbone patterned brickwork with similar walks leading to the doorway and side brick patio.
