

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a Latin Cruci form shaped building in a Victorian version of 13th century Early English Gothic, but trimmed in the Richardson Romanesque style with round rock faced arches, ribbon windows, plain massive chimney, a square tower with pyramidal roof, round turrets and general massiveness. It consists of a tall, 1-1/2 story front section approximately three bays wide and seven bays in depth with the rear section five bays wide and four bays in depth. To the left of the front facade is a one bay square pedimented side porch and a tall, square brick chimney. On the right side is a one bay wide, four bay long extension consisting of a pedimented entrance porch, one story round tower extension, and the one bay square tower, approximately three stories high. To the left of the rear cross section is a two bay wide, four bay deep, one story newer extension of the same design and material. On the right side is a three bay wide, four bay deep one story newer extension similar to that on the left. On the rear facade, the central three bays are projected with low pedimental sections on each end rising before the central gable projection of the main roofline. All walls are buttressed on the end sections. All entrances have paneled doors and round arched transoms with panes similar to the windows and the main entrance on the right side is now approached by eight cement steps. The front facade has a set of three tall, round arched windows and all other windows are narrow, round arched except those on the newer side extensions which have flat arches and most are in sets of three. All window sash is of a small paned, round arched  design of golden yellow stained glass which gave this writer the illusion of sun beams when a child. These windows have three to six row brick header arches. The center bay of the rear facade is adorned by a large stained glass window of the "Good Shepherd." The three storied tower is attached to the right side of the front section with the top section vented by round arched louvers and enhanced by engaged brick columns topped by turrets at the four corners. This has a pyramidal shaped roof topped by a bronze finial and a wrought iron decorated cross. The center of the cross-shaped roofline is accented by a round lantern recently enclosed. This is topped by a pinnacle, shingled and crowned by a bronze finial  as on the turrets of the tower. All roofing is of steep "A" frame construction covered by slate, and all gables and pediments are capped by brownstone crowned by acroteria.  One bay wide pedimented brick dormers with round arched louvers extend from the rear of the front section roof to the left and right. The building is constructed of red, unpainted brick richly trimmed by ashlar-faced brownstone, probably from Connecticut as is the nearby Lutherna Church. This is displayed by a broad band at the base of the front pediment, pediment coping, window sills, arches and hoodmoulds, foliated impost blocks, and all buttress caps and acroteria. This building sets on a high exposed fieldstone foundation. It is fronted by a brick sidewalk in a herringbone design. To the rear is a large lawn area, formerly the church burying ground with some stones remaining against the old fieldstone wall.
